Your Directors are pleased to present the tenth Annual Report with the audited financial statements of the Company for the year ended 31st March 2022.

## **REVIEW OF OPERATIONS**

In spite of the hurdles caused by the Covid 19 pandemic, your Company was able to secure a net profit of Rs. 4,41,95,000 which is 92.43% of previous year profit of Rs. 4,78,14,000.

Your Directors wish to inform you that during the financial year 2021-22, Hon'ble Chief Minister, Shri.Pinarayi Vijayan has inaugurated two prestigious projects of our company i.e., Arippara Small Hydro Project of 4.5MW capacity at Kozhikode and 12MWp Solar Power Project at Payyannur. The Payyannur Solar plant is South India's first terrain-based installation. Your company has achieved a major milestone of generating 25 crore units of green power from the solar and hydroelectric power plants during the current financial year.

Your directors wish to inform you that the company proposes to diversify into tourism and logistics sectors and steps have been initiated.

## **IMPACT OF COVID-19**

Your company has entered into a Power Purchase Agreement with the holding company for the sale of power generated from the solar power plants. The Covid pandemic had impacted the power requirement of holding company because of reduced air traffic and therefore the excess power generated had to be injected into the grid for which the State Electricity Board will only compensate with a lower tariff. This has impacted the revenue of the company for the current financial year.

## **DIVIDEND AND TRANSFER TO RESERVES**

Your Directors have considered it financially prudent in the long-term interests of the Company to reinvest the profits into the business of the Company to build a strong reserve base for the growth of the business. No dividend has therefore been recommended for the year ended 31<sup>st</sup> March 2022 and no amounts have been transferred to Other Equity Account.

## **DIRECTORS' RESPONSIBILITY STATEMENT**

To the best of their knowledge and belief and according to the information and explanations obtained by them, your Directors make the following statements in terms of Section 134(5) of the Companies Act 2013:

- a) in the preparation of the annual accounts for the financial year ended 31<sup>st</sup> March 2022, the applicable accounting standards and the instructions provided under Schedule III of the Companies Act 2013 have been followed and there are no material departures from the same;
- b) the Directors have selected such accounting policies and applied them consistently and made judgments and estimates that are reasonable and prudent so as to give a true and fair view of the state of affairs of the Company as at 31st March 2022 and of the profit of the Company for the year ended on that date;
- the Directors have taken proper and sufficient care for the maintenance of adequate accounting records in accordance with the provisions of the Companies Act 2013 for safeguarding the assets of the Company and for preventing and detecting fraud and other irregularities;
- d) the Directors have prepared the annual accounts on a 'going concern' basis;
- e) the Directors have laid down internal financial controls to be followed by the Company and that such internal financial controls are adequate and are operating effectively and
- f) the Directors have devised proper systems to ensure compliance with the provisions of all applicable laws and that such systems are adequate and operating effectively.

The Company has in place adequate internal financial controls with reference to financial statements. During the year, such controls were tested and no reportable material weakness in the design or operation was observed.

In terms of the provisions of Sub Section 6 of Section 152 of the Companies Act 2013, two – third of the total number of Directors excluding Independent Directors, are liable to retire by rotation and out of which one third has to retire by rotation at every Annual General Meeting. Sri. Saji Daniel (DIN: 09110803) is therefore liable to retire by rotation during the current Annual General Meeting, being eligible offer himself for re-appointment. The Board therefore recommends his re-appointment as Director of the Company.

Sri.V.J.Kurian submitted his letter of resignation dated 02<sup>nd</sup> September 2021 expressing his willingness to relinquish from the post of Chairman and Managing Director of CIAL Infrastructures Limited and the same was accepted by the Board. During the 44<sup>th</sup> Board Meeting of CIAL Infrastructures Limited held on 16<sup>th</sup> September 2021, the Board appointed Sri.S Suhas IAS as Additional Director and Executive Chairman of the Company for a period of 5 years. In accordance with the provisions of Section 161 of Companies Act 2013, Sri.S.Suhas IAS shall hold office up to the date of the forthcoming Annual General Meeting. The Company has received a notice in writing from a member proposing the candidature of Sri.S.Suhas IAS for the office of Director and Executive Chairman under the provisions of Section 160 of the Companies Act 2013 for a period of 5 years with effect from 16<sup>th</sup> September 2021. Therefore, the Board recommends the resolution in relation to the appointment of Sri.S.Suhas IAS as Director and Executive Chairman of the Company for the approval of the shareholders.

The tenure of the Independent Directors of the Company Smt.A.K.Ramani (DIN: 07188269) and Smt.Jolly Thomas (DIN: 07188260), had expired on 01<sup>st</sup> September 2021. During the 45<sup>th</sup> meeting of the Board of Directors of the Company held on 22<sup>nd</sup> November 2021, Sri.A.N.K Kaimal (DIN: 00043820) and Smt.Annie Abraham (DIN: 08493144) were appointed as Independent Directors (Additional Directors) of the Company for a period of 3 years with effect from 22<sup>nd</sup> November 2021.

Sri.A.N.K Kaimal and Smt.Annie Abraham shall hold office up to the date of the current Annual General Meeting and is to be appointed as an Independent Director for a period of 3 years upto the conclusion of the Annual General Meeting to be held in the year 2025.

Necessary resolutions for the appointment of the aforesaid directors are included in the notice convening the Annual General Meeting of the Company.

Other than the above, there were no changes in the Board of Directors and Key Managerial Person (KMP) during the financial year 2021 - 22 and thereafter.

## **Declaration of Independent Directors**

The Independent Directors of the Company, Sri.A.N.K Kaimal (DIN: 00043820) and Smt.Annie Abraham (DIN: 08493144) have furnished declaration(s) to the Board that they meet the 'criteria of independence' as provided in sub-section (6) of Section 149. In the opinion of the Board, the Independent Directors fulfil the conditions specified in the Companies Act 2013. Pursuant to the notification of the Ministry of Corporate Affairs dated 22<sup>nd</sup> October 2019, an online data bank for the independent directors ("Data Bank") has been rolled out by the Indian Institute of Corporate Affairs and these two Independent Directors of the Company had registered themselves in the Data Bank. The Online Proficiency Self-assessment Test has to be qualified by the Independent Directors within a period of two years from the date of registration with the IICA.

## Director's appointment and remuneration

The policy relating to appointment of Directors, payment of Managerial remuneration, Directors qualifications, positive attributes, independence of Directors and other related matters is in compliance with Section 178(3) of the Companies Act 2013. ## **Statutory Auditor**

#### **Internal Auditor**

The Board of Directors of your Company has appointed M/s. Nayar & Menon, Chartered Accountants, Ernakulam (Firm Registration No:002454S) as Internal Auditor pursuant to the provisions of Section 138 of Companies Act 2013 for the financial year 2022-23.

## **Energy Conservation initiatives by CIAL Infrastructures Limited**

- Transformers for the Solar Power evacuation has used Special Laser Scribed Cores for minimizing
  the no load losses. During night time when plant is not operational and the transformers are in line
  with no load conditions, this would reduce the losses incurred. Transformers are also hermetically
  sealed type to reduce the maintenance.
- 2. String inverters are used for the new installations to improve DC/AC conversion which has high conversion efficiency and also to reduce DC cable losses.
- 3. High efficiency air conditioner system with scroll compressor has been used in the Office at airport premises, instead of conventional rotary type systems.
- 4. Vertical blinds are provided for entire glass area for reducing heat load, which in turn reduces capacity of air conditioning system.
- 5. High luminous efficiency LEDs are used for lightings at offices and Solar PV Plant control rooms.
- 6. Saved approximately 40,000 MT of CO<sub>2</sub> during the last financial year from solar initiatives.
- 7. Solar Carports illumination in front of T1 & T3 Terminals were using high efficiency LED lights.
- 8. Power Evacuation of Payyannur Solar Plant and Arippara SHEP are evacuated at 33kV Voltage level to reduce transmission loss.
- CIAL Infra's Energy Policy strives to achieve judicious utilization of energy within the organization by design and practice. It also lays emphasis on maximum utilization of renewable energy across the organization.
- 10. Each and every employee of CIAL Infra is committed to energy conservation efforts as every unit of energy saved for the next generation.

During the period under review, CIAL Infrastructures Limited has spent approximately Rs.10 lakhs towards capital expenditure on energy conservation measures.

#### **NOTES TO FINANCIAL STATEMENTS:**

#### 1. GENERAL INFORMATION

CIAL Infrastructures Limited is a public limited company incorporated and domiciled in India. It is a wholly owned subsidiary of Cochin International Airport Limited. The address of its registered office is XI/318E, Cochin International Airport Buildings, Kochi Airport P.O., Ernakulam District, Pin-683111 and the principal place of business is located in Nedumbassery, Kochi-683 111.

The company is engaged in the generation and sale of renewable energy. The company has eight Solar power plants in the premises of Cochin International Airport having an aggregate capacity of 38.5 MWp and one Solar power plant at Payyannur in Kannur district having a capacity of 11.5 MWp. Thus, the total Solar power plant capacity of the company is 50 MWp. Apart from this, the company has commissioned a Small Hydro Electric Power plant of capacity 4.5 MW at Arippara, in Kozhikode District.

The financial statements were approved for issue by the Company's Board of Directors on 27th May 2022.

#### 2. SIGNIFICANT ACCOUNTING POLICIES:

## **Basis of Preparation and presentation**

# a) Statement of compliance

These financial statements have been prepared in accordance with the Indian Accounting Standards (referred to as "Ind AS") as prescribed under Section 133 of the Companies Act 2013 read with Companies (Indian Accounting Standards) Rules as amended from time to time.

#### b) Basis of Measurement

The financial statements have been prepared on a historical cost convention and on an accrual basis, except for the following material items that have been measured at fair value as required by relevant Ind AS:

- i. Defined benefit and other long-term employee benefits.
- ii. Property, plant and equipment with different useful lives.

#### c) Use of Estimates and judgment

The preparation of financial statements in conformity with Ind AS requires management to make judgments, estimates and assumptions that affect the application of accounting policies and the reported amounts of assets, liabilities, income and expenses. Actual results may differ from these estimates. Estimates and underlying assumptions are reviewed on a periodic basis. Revisions to accounting estimates are recognized in the period in which the estimates are revised and in any future periods affected. In particular, information about significant areas of estimation, uncertainty and critical judgments in applying accounting policies that have the most significant effect on the amounts recognized in the financial statements is included in the following notes:

# (i) Revenue Recognition

Revenue from Sale of power is recognized at the point of completion of agreed services. Interest income on deposits is recognized on time proportion basis. Revenue from sale of

tender documents is recognized on effecting the delivery of the same. Consultancy income is recognized at the point of completion of agreed services.

### (ii) Property, plant and equipment

#### a) Recognition and measurement:

Property, plant and equipment are measured at cost less accumulated depreciation and impairment losses, if any. Cost includes expenditures directly attributable to the acquisition of the asset.

#### b) Depreciation

The Company depreciates property, plant and equipment over the estimated useful life on a straight-line basis from the date the assets are ready for intended use. Assets being leasehold improvements are amortized over the lower of estimated useful life and lease term.

The estimated useful lives of assets for the current and comparative period of significant items of property, plant and equipment are as follows:

Depreciation methods, useful lives and residual values are reviewed at each reporting date.

When parts of an item of property, plant and equipment have different useful lives, they are accounted for as separate items (major components) of property, plant and equipment from 01.04.2016 onwards. During Financial Year 2016 - 17, the useful life of string inverters of solar power plant was assessed as 10 years and it was componentized from solar power plant. For the solar power plant at Payyannur, capitalised during Financial Year 2021 - 22, the useful life of inverters have been certified by the expert as the same as that of the solar power plant and hence no componentization has been done. Subsequent expenditure relating to property, plant and equipment is capitalized only when it is probable that future economic benefits associated with these will flow to the Company and the cost of the item can be measured reliably. Repairs and maintenance costs are recognized in the statement of profit and loss when incurred. The cost and related accumulated depreciation are eliminated from the financial statements upon sale or disposition of the asset and the

resultant gains or losses are recognized in the statement of profit and loss. Amounts paid towards the acquisition of property, plant and equipment outstanding as of each reporting date and the cost of property, plant and equipment not ready for intended use before such date are disclosed under capital work-in-progress. The decommissioning cost have not been capitalised as it is insignificant considering the carrying amount of assets. For the Small Hydro Electric plant at Arippara capitalised during Financial Year 2021 - 22, useful life is assessed as 23 years, as this is the remaining BOOT period of the plant. The interest cost on Arippara term loan till the date of commissioning of this project, has been capitalised.

#### (iii) Intangible assets

Intangible assets are stated at cost less accumulated amortization and impairment. Intangible assets are amortized over their respective estimated useful lives on a straight line basis, from the date that they are available for use. The estimated useful life of an identifiable intangible asset is based on a number of factors including the effects of obsolescence, demand, competition and other economic factors (such as the stability of the industry and known technological advances) and the level of maintenance expenditures required to obtain the expected future cash flows from the asset.

The estimated useful lives of intangibles are as follows:

#### (iv) Inventories

Inventories have been valued at lower of cost and net realisable value. The cost arrived is including production overheads. Net realisable value is the average pooled power purchase cost of KSEB, as per the regulation of Kerala State Electricity Regulatory Commission.

#### (v) Employee Benefits

- a. Short term employee benefits such as salaries, wages, bonus and incentives which fall due within 12 months of the period in which the employee renders the related services which entitles him to avail such benefits are recognized on an undiscounted basis and charged to the profit and loss account.
- Defined Contribution Plans Contributions made to the Recognized Provident Fund are expensed to the Profit and Loss Account. The Company's obligation is limited to the amount contributed by it.
- c. Defined Benefit Plans The net present value of the obligation for gratuity benefits as determined on independent actuarial valuation, conducted using the projected unit credit method, as adjusted for unrecognized past services cost, if any, is recognized in the books of account. Actuarial gains and losses are recognized in full in the Statement of Profit and Loss for the period in which they occur.
- d. Long Term Employee Benefits The Company has a policy on compensated absence which are both accumulating and non-accumulating in nature. The expected cost of accumulating compensated absences is determined by actuarial valuation performed by an independent actuary at each Balance Sheet date using projected unit credit method on the additional amount expected to be paid / availed as a result of the unused entitlement that has accumulated at the Balance Sheet date. Expense on non-accumulating compensated absences is recognized in the period in which the absences occur.

#### (vi) Foreign Exchange Transactions

Transactions in foreign currency are accounted at the exchange rates prevailing on the date of the transaction. Monetary assets and liabilities denominated in foreign currency are translated at the exchange rate prevailing on the last date of the accounting year and the resultant exchange difference, if any, are recognized in the Statement of Profit and Loss.

#### (vii) Earnings per share

The earnings considered in ascertaining the company's Earnings per share comprise of the net profit after tax. The number of shares used in computing the basic earnings per share is the weighted average number of equity shares outstanding during the year. The number of shares used in computing diluted Earnings per share comprises the weighted average shares considered for deriving the basic earning per share and also the weighted average number of shares, which would have been issued on the conversion of all dilutive potential equity shares.

#### (viii) Taxes on Income:

Income tax expense comprises of current tax and deferred tax charge or credit. The current tax is determined as the amount of tax payable in respect of the estimated taxable income of the period. The deferred tax charge or credit is recognised using prevailing enacted or substantively enacted tax rates. Where there are unabsorbed depreciation or carry forward losses, deferred tax assets are recognised only if there is virtual certainty of realization of such assets. Other deferred tax assets are recognised only to the extent there is reasonable certainty of realisation in future. Deferred tax assets are reviewed at each Balance Sheet date based on the developments during the period. Deferred tax in respect of timing differences, which originate and reverse during a tax holiday period, are not recognized to the extent the gross total income is subject to the deduction during the tax holiday period.

MAT Credit is recognized as an asset only when and to the extent there is convincing evidence that the company will pay normal income tax during the specified period. In the year in which the MAT Credit becomes eligible to be recognised as an asset in accordance with the recommendations contained in the guidance note issued by The Institute of Chartered Accountants of India, the said asset is credited by way of a credit to the profit and loss account and shown as MAT Credit Entitlement. The company reviews the same at each Balance Sheet date and writes down the carrying amount of MAT credit entitlement to the extent there is no longer convincing evidence to the effect that company will pay normal Income Tax during the specified period.

The MAT credit for the year ended 31.03.2022 is Rs.10,417,000/- which is credited to Profit and Loss account and shown as MAT credit entitlements and there is convincing evidence that the company will pay normal Income Tax during the specified period.

#### (ix) Impairment of Assets

The carrying amount of assets is reviewed at each Balance Sheet date if there is any indication of impairment based on internal or external factors. An impairment loss will be recognized wherever the carrying amount of an asset exceeds its estimated recoverable amount. The recoverable amount is greater of the assets net selling price and value in use. In assessing the value in use, the estimated future cash flows are discounted to the present value using the weighted average cost of capital.

#### (x) Provisions, Contingent Liabilities and Contingent Assets

The company creates a provision when there is a present obligation as a result of past event that probably requires an outflow of resources and a reliable estimate can be made of the amount of obligation. A disclosure for a contingent liability is made when there is a possible obligation that may but probably will not require an outflow of resources. When there is a possible obligation or a present obligation in respect of which the likelihood of outflow of resources is remote, no provision or disclosure is made. Contingent assets are disclosed in the accounts, where an inflow of economic benefits is probable.

#### (xi) Cash and cash equivalents

Cash and cash equivalents comprise of cash and cash on deposit with banks and financial institutions. Fixed Deposit with banks is split into up to 3 months, between 3 to 12 months and more than 12 months.

#### (xii) Cash Flow Statement

Cash flows are reported using the indirect method, whereby profit before tax is adjusted for the effects of deferrals or accruals of past or future operating cash receipts or payments and item of income or expenses associated with investing or financing cash flows. The cash flows from operating, investing and financing activities of the Company are segregated.

#### (xiii) Leases

The Company evaluates if an arrangement qualifies to be a lease as per the requirements of Ind AS 116. Identification of a lease requires significant judgment. The Company uses significant judgment in assessing the lease term (including anticipated renewals) and the applicable discount rate.

The Company determines the lease term as the non-cancellable period of a lease, together with both periods covered by an option to extend the lease if the Company is reasonably certain to exercise that option; and periods covered by an option to terminate the lease if the Company is reasonably certain not to exercise that option. In assessing whether the Company is reasonably certain to exercise an option to extend a lease, or not to exercise an option to terminate a lease, it considers all relevant facts and circumstances that create an economic incentive for the Company to exercise the option to extend the lease, or not to exercise the option to terminate the lease. The Company revises the lease term if there is a change in the non-cancellable period of a lease.

The discount rate is generally based on the incremental borrowing rate specific to the lease being evaluated or for a portfolio of leases with similar characteristics.

#### (xiv) Corporate Social Responsibility (CSR) Expenses

As per Section 135 of the Companies Act 2013, a CSR Committee has been formed by the company. The amount spent during the year for CSR activities is Rs.1,782,000/- and the same has been charged off to the Profit and Loss Account.

# (xv) Risk Management

The Company's activities expose it to a variety of risks: credit risk, liquidity risk, and performance risk of contracts.

Credit risk is the risk of financial loss to the Company if a customer or counterparty to a financial instrument fails to meet its contractual obligations and arises principally from the Company's receivables from customers and investment securities. Credit risk arises from cash held with banks and financial institutions, as well as credit exposure to clients, including outstanding accounts receivable. The maximum exposure to credit risk is equal to the carrying value of

the financial assets. The objective of managing counterparty credit risk is to prevent losses in financial assets. The Company assesses the credit quality of the counterparties, taking into account their financial position, past experience and other factors.

Liquidity risk is the risk that the Company will not be able to meet its financial obligations as they become due. The Company manages its liquidity risk by ensuring, as far as possible, that it will always have sufficient liquidity to meet its liabilities when due.

Hydroelectric Projects have often been accused of indulgence in time and cost overrun resulting ultimately in delay in availability of power as well as in higher cost of power. Main contributing factors to the alleged ubiquitous over-run include delay in timely availability of statutory approvals, resettlement and rehabilitation factors, land acquisition problems and project management and implementation decisions. Processes and policies related to such risks are overseen by senior management.

#### (xvi) Estimation of uncertainties relating to the global health pandemic from Covid-19

The Company has considered the possible effects that may result from the pandemic relating to Covid-19 in the preparation of these standalone financial statements including the recoverability of carrying amounts of financial and non-financial assets. In developing the assumptions relating to the possible future uncertainties in the global economic conditions because of this pandemic, the Company has, at the due date of approval of these financial statements, used internal and external sources of information including credit reports and related information and economic forecasts and expects that the carrying amount of these assets will be recovered.

#### 3. APPLICATION OF NEW ACCOUNTING PRONOUNCEMENTS

The Ministry of Corporate Affairs (MCA) on 18<sup>th</sup> June 2021 has issued new Companies (Indian Accounting Standard) Amendment Rules 2021. These rules shall be applicable with immediate effect from the date of the notification i.e., 18<sup>th</sup> June 2021 which means that the amendments are effective for the financial year ended 31<sup>st</sup> March 2022 onwards.

Major amendments notified in the Companies (Ind AS) Amendment Rules 2021 are provided below: -

- (c) Ind AS 34 | Interim Financial Reporting The amendments to this standard are made in reference to the conceptual framework of Financial Reporting in Ind AS.
- (d) Ind AS 37 | Provisions, Contingent Liabilities and Contingent Assets The amendment substitutes the definition of the term 'Liability' as provided in the Conceptual Framework for Financial Reporting under Indian Accounting Standards.
- (e) Ind AS 38 | Intangible Assets The amendment substitutes the definition of the term 'Asset' as provided in the Conceptual Framework for Financial Reporting under Indian Accounting Standards.
- (f) Ind AS 101 | Presentation of Financial Statements The amendment substitutes the item (d) mentioned in paragraph BI as 'Classification and measurement of financial instruments'. The term 'financial asset' has been replaced with financial instruments.

- (g) Ind AS 102 | Share-Based Payment The amendments to this standard are made in reference to the Conceptual Framework of Financial Reporting under Ind AS in terms of defining the term 'Equity Instrument' which shall be applicable for the annual reporting periods beginning on or after 01st April 2021.
- (h) Ind AS 103 | Business Combinations The amendment substitutes the definition of 'assets' and 'liabilities' in accordance with the definition given in the framework for the Preparation and Presentation of Financial Statements in accordance with Ind AS for qualifying the recognition criteria as per acquisition method.
- (i) Ind AS 104 | Insurance Contracts The amendment covers the insertion of certain paragraphs in the standard in order to maintain consistency with IFRS 4 and also incorporates the guidance on accounting treatment for amendments due to Interest Rate Benchmark Reform.
- (j) Ind AS 105 | non-current assets held for sale and discontinued operations The amendment substitutes the definition of "fair value less costs to sell" with "fair value less costs of disposal"
- (k) Ind AS 106 | Exploration for and evaluation of mineral resources The amendment has been made in reference to the Conceptual Framework for Financial Reporting under Indian Accounting Standards in respect of expenditures that shall not be recognized as exploration and evaluation assets.
- (I) Ind AS 107 | Financial Instruments: Recognition, Presentation and Disclosure The amendment clarifies the certain additional disclosures to be made on account of Interest Rate Benchmark Reform like
  - (i) the nature and extent of risks to which the entity is exposed arising from financial instruments subject to interest rate benchmark reform.
  - (ii) the entity's progress in completing the transition to alternative benchmark rates, and how the entity is managing the transition.
- (m) Ind AS 109 | Financial Instruments The amendment provides a practical expedient for assessment of contractual cash flow test, which is one of the criteria for being eligible to measure a financial asset at amortized cost, for the changes in the financial assets that may arise as a result of Interest Rate Benchmark Reform along. An additional temporary exception from applying hedge accounting is also added for Interest Rate Benchmark Reform.
- (n) Ind AS 111 | Joint Arrangements In order to maintain consistency with the amendments made in Ind AS 103, respective changes have been made in Ind AS 111.
- (o) Ind AS 114 | Regulatory Deferral Accounts The amendment clarifies that an entity may only change its accounting policies for the recognition, measurement, and impairment & derecognition of regulatory deferral account balances if the change makes the financial statements more relevant to the economic decision-making needs of users and no less reliable.
- (p) Ind AS 115 | Revenue from Contracts with Customers Certain amendments have been made in order to maintain consistency with number of paragraphs of IFRS 15.
- (q) Ind AS 116 | Leases The amendments extend the benefits of the Covid-19 related rent concession that were introduced last year (which allowed lessees to recognize Covid-19 related rent concessions as income rather than as lease modification) from 30<sup>th</sup> June 2021 to 30<sup>th</sup> June 2022.

The amendments are made with an intention to align the Ind ASs with the amendments made in IFRS. While, largely, the amendments are clarificatory or editorial in nature, there are significant amendments relating to the extension of Covid-19 related to practical expedient under Ind AS 116 for lease concessions and practical expedient due to the interbank offered rate (IBOR) interest rates for financial instruments.

These banked units can be withdrawn and consumed during the immediately following financial year. These banked solar power units as on 31.03.2022 is treated as inventory and the same is stated at lower of Cost and Net Realisable Value. The cost arrived at by the management is the direct cost including production overheads which is Rs.2.30 per unit. The net realisable value is the Average Pooled Power Purchase Cost (APPC) of KSEB as per Kerala State Electricity Regulatory Commission tariff order, which is Rs 3.22 per unit. The inventory is valued at cost of Rs 2.30 per unit to arrive at the closing stock value of 7207 K INR.

#### 33. SALE OF POWER FROM ARIPPARA SHEP (4.5 MW)

The connectivity agreement for Arippara SHEP (4.5 MW) was signed by CIAL Infra with KSEBL on 04<sup>th</sup> August 2021. Thereafter, the plant was synchronised with the grid on 05<sup>th</sup> August 2021 and the power generated by Arippara plant started getting evacuated into the KSEBL grid from the said date. The Commercial Operation Date (COD) of Arippara SHEP (4.5 MW) was declared with effect from 13<sup>th</sup> October 2021, after getting Board order from KSEBL for declaration of COD. Arippara SHEP has been capitalised in our books of accounts as on the date of COD. As per KSERC (Renewable Energy and Net Metering) Regulations 2020, the generic tariff for "Small Hydro Electric Projects having installed capacity of and below 5 MW" is Rs. 5.53 per unit. But this "tariff" as well as "Power Purchase Agreement" have to be approved by Kerala State Electricity Regulatory Commission (KSERC). In October 2021, we have filed petition with KSERC for "determining generic tariff and also to approve PPA for Arippara SHEP". This petition is pending before KSERC. From the date of synchronisation to COD, we have exported 3,702,900 units to KSEBL grid and from the date of COD till 31<sup>st</sup> March 2022, we have exported 2,600,500 units to the grid. In the absence of approved tariff & PPA, these units injected into KSEBL grid has not been billed. Hence, revenue of Rs. 348.58 lakhs from Arippara SHEP, has not been recognized in the Statement of Profit & Loss for the current year, pending approval of tariff and PPA by Regulatory Commission.

#### 34. SALE OF POWER FROM PAYYANNUR SOLAR PLANT (11.6 MWp)

The solar power plant of 11.6 MWp capacity at Payyannur was originally envisaged as a "captive power plant" for meeting the increasing power requirements of our parent company, Cochin International Airport Ltd (CIAL). Unfortunately, Covid-19 pandemic has upset CIAL's business plans and has also made their energy consumption to go on a reverse gear. Therefore, we converted this plant to an "Independent Power Plant" (IPP) and we are presently having negotiations with KSEBL, for sale of solar power from this plant for a short period of one year. KSEBL is interested in buying power from our Payyannur solar plant, for meeting their solar RPO (Renewable Purchase Obligation). In a period of one year, we expect airport operations and energy consumption to go up drastically and then this energy can be wheeled and consumed by CIAL at airport. Payyanur power plant was capitalized in our books of accounts with effective date as 05th March 2022, which is the date on which the State Load Despatch Centre (SLDC) gave us permission for injection of infirm power into the grid. The declaration of COD for the plant was on 13th November 2021. From the date of declaration of COD till we received permission for injection of infirm power, we have exported 4,779,800 units to KSEBL grid and from the date of injection of infirm power till 31st March 2022, we have exported 1,296,800 units to the grid. We expect to get this regularized in our books, once we enter into a Power Purchase Agreement (PPA) with KSEBL.

# 35. DISCLOSURE UNDER IND AS 116: LEASES

#### **Transition to Ind AS 116**

Ministry of Corporate Affairs ("MCA") through Companies (Indian Accounting Standards) Amendment Rules 2019 and Companies (Indian Accounting Standards) Second Amendment Rules, has notified Ind AS 116 Leases which replaces the existing lease standard, Ind AS 17 Leases, and other interpretations. Ind AS 116 sets out the principles for the recognition, measurement, presentation and disclosure of leases for both lessees and lessors. It introduces a single, on-balance sheet lease accounting model for lessees. The Company has adopted Ind AS 116, effective annual reporting period beginning April 1, 2019 and applied the standard to its leases, retrospectively, with the cumulative effect of initially applying the standard, recognised on the date of initial application (April 1, 2019). Accordingly, the Company has not restated comparative information, instead, the cumulative effect of initially applying this standard has been recognised as an adjustment to the opening balance of retained earnings as on April 1, 2019.

#### Company as a Lessee

For transition, the Company has elected not to apply the requirements of Ind AS 116 to leases which are expiring within 12 months from the date of transition by class of asset. The Company has also used the practical expedient provided by the standard when applying Ind AS 116 to leases previously classified as operating leases under Ind AS 17 and therefore, has not reassessed whether a contract, is or contains a lease, at the date of initial application, relied on its assessment of whether leases are onerous, applying Ind AS 37 immediately before the date of initial application as an alternative to performing an impairment review, excluded initial direct costs from measuring the right-of-use asset at the date of initial application and used hindsight when determining the lease term if the contract contains options to extend or terminate the lease. The Company has used a single discount rate to a portfolio of leases with similar characteristics.

On transition, the Company recognised a lease liability measured at the present value of the remaining lease payments. The right-of-use asset is recognised at its carrying amount as if the standard had been applied since the commencement of the lease, but discounted using the lessee's incremental borrowing rate as at April 1, 2019. Accordingly, a right-of-use asset of Rs. 8,757 K INR and a correspond lease liability of Rs. 9,546 K INR has been recognized. The cumulative effect on transition in retained earnings net off taxes is Rs. 1,008 K INR (including a deferred tax of Rs. 219 K INR). Borrowing rate of 8.25% has been applied to lease liabilities recognised in the balance sheet at the date of initial application.

On application of Ind AS 116, the nature of expenses has changed from lease rent in previous periods to depreciation cost for the right-of-use asset and finance cost for interest accrued on lease liability.

The difference between the future minimum lease rental commitments towards non-cancellable operating leases and finance leases reported as at March 31, 2019 compared to the lease liability as accounted as at April 1, 2019 is primarily due to inclusion of present value of the lease payments for the remaining term of the leases, reduction due to discounting of the lease liabilities as per the requirement of Ind AS 116 and exclusion of the commitments for the leases to which the Company has chosen to apply the practical expedient as per the standard.

#### 41. TERM LOANS FROM BANK

The term loans represent the disbursement of two term loans sanctioned by M/s Federal Bank Limited.

- i) A term loan of Rs. 35 crores was sanctioned for the execution of SHEP project at Arippara, Kozhikode. The period of this term loan is 144 months and the present interest rate is 6.35% per annum (P.Y. 8.15% per annum). The term loan is repayable in 22 half yearly installments and the first such installment shall commence after 13 months from the date of first disbursement of loan. Accordingly, the repayment had started in Sep 2019. The total amount availed from this term loan till 31st March 2022 is Rs. 35 crores and the amount outstanding in this term loan account as on 31st March 2022 is Rs. 28 crores. Interest is charged and duly paid every month. The interest till date of capitalisation (13th Oct 2021) has been booked under Arippara Capital WIP as Interest During Construction period. The interest after capitalisation date is debited to the Statement of Profit & Loss for the current year. The term loan is primarily secured by equitable mortgage on 6.69 acres of project land at Arippara, Kozhikode and other project assets situated on this land. The collateral security is extension of charge on entire current assets of the company, which is already charged for availing overdraft facility of Rs. 5 crores from Federal Bank Limited.
- ii) A term loan of Rs. 150 crores was sanctioned in July 2020, for meeting the capex requirements of new solar plants. The term loan is repayable in 144 monthly installments and the present interest

rate is 6.35% per annum (P.Y. 7.8% per annum). The total amount availed from this term loan till 31st March 2022 is Rs. 65 crores and the amount outstanding in this term loan account as on 31st March 2022 is Rs. 56.67 crores. The loan is secured by hypothecation of entire current assets, entire movable fixed assets presently owned by CIAL Infrastructures Ltd, cash flows of CIAL Infrastructures Ltd and Hypothecation of receivables from CIAL through escrow mechanism.

iii) The principal amount repayable in the next one year is shown under Current Liabilities under the head "Other financial liabilities" and the balance amount is shown under Non current Liabilities. The details of the same are given below:-

The premium thus retained by Power department for above two SHEPs along with initial expenses like topographic survey charges and consultancy charges for DPR preparation, amounting to Rs. 20,833 K INR, has been charged off to our Statement of Profit & Loss for the year ended 31.03.2021 under the head "Loss on capital WIP Sold/Discarded".
